Councilwoman Howard summarized that a few years ago a moratorium was placed on events, recalled considering the women's club to give it purpose and that Dawn declined the variance offer, the ordinance would have to be changed, however there was no interest to do it at that time. Dawn would like to revisit this to apply for the Women's Club and her personal home for wedding events.
